OTHER BUSINESS NOT ON WRITTEN AGENDA

Audience Participation (5 Minute Limit per Speaker)

Sterling Abernathy- He has comments this evening regarding charter review. Council started setting up a Charter Review Committee to propose changes to the city charter this year. In 2012, Kettering voters changed the city charter to impose term limits on city council. In 2016, Kettering voters approved more citizen initiated charter reforms. Charter amendments from the 2016 Charter Review Committee tried to overturn term limits, but it was rejected by the voters. Today, after eight years after term limits were adopted, only one council seat has changed. Other members of council are term limited once their current term expires. Senior council members have served 14, 17, 23 and 34 years and council will have new faces in 2022 and 2024. This council wants to repeal previous charter reforms and instead of openly proposing charter amendments, this council wants to work indirectly through a committee. How could a committee be impartial when people are handpicked by the Mayor? How can the committee be independent when it is steered by the city manager and the law director to come up with what council wants? Council is not required to use a committee; they can pass legislation to place proposed charter amendments on the ballot. Mr. Klepacz initiated the call for the Charter Review Committee and next month will mark 14 years of his service on city council. If council knows the charter changes they would like to make, they should have the law director draft legislation and get it passed by council so it can be placed on the ballot so the voters can decide. After 14 years of service, you are allowed to be open with the public about the charter changes council would like to make. If council wants citizen input on proposed charter changes, they should hold a meeting for all the public similar to what was done for Ridgeway Bridge. During this pandemic, there is no need to set-up a committee and have the city manager, assistant city manager, law

director and assistant law director spend hours conducting group meetings on Zoom when council can place charter changes on the ballot themselves. If council is going to overturn the seven initiated charter reforms including term limits that the voters overwhelmingly approved in 2012 and 2016, they at least need to be open and upfront about it. Council should not try to hide what they are doing through a committee and waste a lot of time and when that was done in 2016 the Kettering voters still didn't buy it.

Mayor Patterson expressed council has not established a committee and have not discussed proposed charter amendments. Kettering residents have the right to participate in charter changes. He is not in favor of council drafting legislation and passing it to go to the ballot. He believes in democracy and residents have the right to put together and make changes they think need to be made. Any changes to the charter will not affect anyone currently serving on council including term limits. There isn't an ulterior motive for current council members to continue to serve on council.
