AUTHORIZING THE CITY MANAGER TO USE COMPETITIVE BARGAINING AND NEGOTIATED QUOTES TO CONTRACT FOR UPDATES TO THE KETTERING FIRE DEPARTMENT'S SIREN ALERT SYSTEM

WHEREAS, in Resolution Nos. 10408-20 and 10533-21, this City Council approved and authorized the City Manager to apply for and accept a FEMA Hazard Mitigation Grant through the Ohio Emergency Management Agency (OEMA) for the Hazard Mitigation Grant Program (HMGP) CFDA 97.039 FEMA-DR-4447-OH (Project); and

WHEREAS, said grant funds will assist in the update and/or replacement of outdated components of the Kettering Fire Department's siren alert system; and

WHEREAS, Federal funding will be provided in the amount of \$24,479, as well as \$4,080 by the State of Ohio, and \$4,080 by the City;

NOW, THEREFORE, Be It Resolved by the Council of the City of Kettering, State of Ohio, that:

Section 1. On the basis that the City can often obtain lower prices and more favorable purchasing conditions through competitive bargaining and negotiated quotations than through sealed bids, the City Manager is hereby authorized to use such bargaining and negotiation procedures and to enter into one or more contracts for updates and/or replacement of outdated components of the Kettering Fire Department's siren alert system. # AUTHORIZING THE CITY MANAGER TO ADVERTISE FOR BIDS AND TO CONTRACT FOR THE RENOVATION OF THE ROSEWOOD ARTS CENTRE

WHEREAS, in Resolution No. 10425-20, this City Council approved and authorized the City Manager to accept and administer a grant from the State of Ohio or its subdivisions for renovation of the Rosewood Arts Centre; and

WHEREAS, the amount budgeted includes the \$450,000 grant from the State of Ohio;

NOW, THEREFORE, Be It Resolved by the Council of the City of Kettering, State of Ohio, that:

Section I. The City Manager is hereby authorized to advertise for bids and to enter into one or more contracts for the renovation of the Rosewood Arts Centre, in accordance with Chapter 152 of the Kettering Administrative Code, titled Purchases and Contracts. The City Manager is further authorized to sign any amendments or extensions thereto that the City Manager deems appropriate.

Section 2. Bids for such project shall be in accordance with the specifications on file in the Department of Finance, office of the Purchasing Manager. Bidding may be conducted electronically. The bids shall be opened at the time and place named in the advertisement for bids, unless extended by the City; or unless, within seventy-two hours prior to the published time for the opening of bids, excluding Saturdays, Sundays, and legal holidays, any modification of the plans or specifications for the project for which bids are solicited is issued and mailed or otherwise furnished to persons who have obtained plans or specifications for the project in which event the time for opening of bids shall be extended one week, with no further advertising of bids required.

Section 3. The City of Kettering shall and does reserve the right (a) to make awards to more than one bidder and to accept a part or parts of a bid, (b) to reject any or all bids so received, (c) to waive any irregularities, informalities, irregularities, or defects in a bid, (d) to hold any bid up to sixty (60) days unless the time for awarding the contract is extended by mutual consent of the City and the bidder whose bid the City subsequently accepts or, (e) to accept that bid which in the judgment of the City Manager is in the best interest of the City.

Section 4. As provided in Section 4-8 of the City Charter, this Resolution shall take effect immediately upon its adoption.

# TO ENACT CHAPTER 125 OF THE CODIFIED ORDINANCES REGARDING CITY COUNCIL COMPENSATION

WHEREAS, Subsection 3-5(b)(1) of the City Charter provides that "Council may increase or decrease the compensation of its members or the Mayor by an ordinance adopted in any odd numbered year no later than June first, provided that no increase in compensation shall be effective during the term of office of the Mayor or Council members in which such vote is taken. This section does not prohibit the payment of increased costs of continuing to provide the identical benefits provided to Council members or the Mayor at the commencement of such member's term of office;" and

WHEREAS, Subsection 3-5(b)(2) of the City Charter provides that "[a]ny ordinance increasing the compensation of Council members or the Mayor shall be limited to the single issue of Council compensation. Such ordinance shall not be passed as an expedited or emergency ordinance;" and

WHEREAS, compensation for the Mayor and at-large Council members has not been adjusted since 2014 and compensation for district Council members has not been adjusted since 2016; and

WHEREAS, members of Council and the Mayor should receive just and reasonable compensation for the work, service, and duties they perform on behalf of the citizens of Kettering, and such compensation is required to attract and retain qualified candidates for elected positions;

NOW, THEREFORE, Be It Ordained by the Council of the City of Kettering, State of Ohio, that:

<u>Section 1.</u> New Chapter 125 of Title One of the Codified Ordinances of Kettering is enacted to read as follows:

CHAPTER 125

COUNCIL COMPENSATION

125.01 Mayor.

Effective with the term beginning on January 1, 2022, the Mayor shall receive an annual salary of \$18,000. Prior thereto, the Mayor shall continue to receive the \$12,000 annual salary set by Charter Section 3-5. Compensation shall be paid on the same schedule used for City employees.

### 125.02 At-Large Council Members.

Effective with the term beginning on January 1, 2022, at-large Council members shall receive an annual salary of \$12,000. Prior thereto, at-large Council members shall continue to receive the \$8,000 annual salary set by Charter Section 3-5. Compensation shall be paid on the same schedule used for City employees.

### 125.03 District Council Members.

Effective with the term beginning on January 1, 2024, district Council members shall receive an annual salary of \$12,000. Prior thereto, district Council members shall continue to receive the \$8,000 annual salary set by Charter Section 3-5. Compensation shall be paid on the same schedule used for City employees.

## 125.04 Supplementary Benefits.

The Mayor and members of Council may purchase voluntary life insurance through the City's group plan at their own expense. The Mayor and members of Council will not receive any other supplementary benefits.

Section 2. Article I, Section N. (Members of Council) of Ordinance No. 4353-20 is repealed.

Section 3. If any section, subsection, sentence, clause, phrase, or portion of this ordinance or Chapter 125 is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

Section 4. As provided in Section 4-8 of the City Charter, this Ordinance shall be effective two weeks after adoption.
