# KETTERING CITY COUNCIL REGULAR MEETING MINUTES May 11, 2021

The Council of the City of Kettering, Ohio, met in regular session on Tuesday, May 11, 2021, at 7:30 p.m. in Council Chambers at the Kettering Government Center South Building, 3600 Shroyer Road. Mayor Patterson presided and the Clerk of Council, LaShaunah D. Kaczynski, recorded. This meeting was telecast live on the cable access channel and streamed live at mvcc.net.

Audience Participation (5 Minute Limit per Speaker)

**Jeffrey Trzeciak- 4524 Royal Ridge Way-** Mr. Trzeciak mentioned he is the new Executive Director for the Dayton Metro Library and a proud Kettering resident. He grew-up in old north Dayton and his family still lives in the region. He has been away for the past 25 years and he is glad to be back. He is very eager to work with city council on addressing the needs of the Kettering community as it pertains to library services. He is happy to finally put names to faces and he is happy to work with the city.

Mayor Patterson mentioned he had a phone conversation with Mr. Trzeciak last week and he is happy he called him.

Mr. Duke mentioned Mr. Trzeciak had an excellent guest editorial in the Dayton Daily News. He is happy to have Mr. Trzeciak aboard at the Dayton Metro Library.

Larry Maloney- 927 E. Dorothy Lane- Mr. Maloney mentioned that he took advantage of the city's compost program. He currently has compost in his front yard and also along the area between the curb and the sidewalk. His beautiful lawn has now turned into weeds. He hadn't made the association for a few years and his lawn looked so bad that he dug up the area between the curb and the sidewalk by 8 inches and filled it up with Kettering compost and placed new sod over it. It was beautiful, but then the following spring his yard started to have weeds again. That is when he made the connection between the city's compost and the weeds that were developing in his yard. Mr. Maloney had a conversation with city staff at Indian Riffle Park and he informed staff that the compost must be to be heated in order to kill the weeds. City staff informed him that the compost is heated up to 120 degrees and it takes a minimal of 130 degrees to kill the weeds in the compost. Elaine Ingham is the world's foremost authority on compost and she teaches information regarding compost to municipalities. He explained the situation to Ms. Ingham and she informed Mr. Maloney that what is in his yard is not compost because in order to kill the weeds, compost must be heated to at least 130 degrees. What the city is making is rotated vegetation. Last year, he emailed this information to his council representative of District 1 and he never heard anything back. He would like to find out the history of this program and he would like to know if this is a government funded program or is something the city is paying for. If you want to make good compost there is protocol you must follow and lacking in steps will not heat the compost up and there are also weed seeds mixed into the compost. Mr. Maloney expressed he is an organic farmer and he would have weeds shoot up overnight that would be very high. This was before he placed the city's compost on his yard, but once he placed the city's compost on his yard he had weeds throughout multiple places in his yard. When he mows his yard on the lowest setting, it wouldn't pickup any of the weeds. Now that city council has been made aware of this problem they have a chance to do something about it. He can provide city staff with Elaine Ingham's contact information for training. He was told that city staff were trained in Waynesville and spent between \$1,500 and \$2,500 to be trained in compost. He called city officials in Waynesville and no one has heard of anyone who teaches classes regarding compost. As it is now, it is a grade below compost and the citizens of Kettering deserve to be made aware of that. There are plenty of lawn care companies that are going around town, and the city could be getting a commission off of that because they are providing lawn care companies with a lot of business since they are not heating the compost correctly.

Mayor Patterson expressed this is the first he has heard of this concern and that the city's compost is from leaves that are picked up throughout the community.

Mr. Schwieterman explained that the city's compost program was instituted several decades ago and it is a collection of leaves and debris. Once collected, yard debris and leaves are hauled over to the leaf site at Miami Valley Research Park and the compost is created out of those items. Mr. Schwieterman appreciates Mr. Maloney's comments this evening and he will be speaking with the public service director to find out more information about the compost process and how employees are trained.

Mr. Duke asked for clarification regarding the city's mulch. There are two types of mulch the city provides.

Mr. Maloney explained there are two types of products the city provides. One is mulch and the other is considered compost. He still uses the city's mulch. He puts a piece of cardboard down then he puts down the mulch to prevent the weeds from coming up.
