WHEREAS: In scleroderma, a patient's immune system becomes overactive and attacks its own tissue through an overproduction of collagen; and

WHEREAS: Scleroderma can develop and is found in every age group from infants to the elderly, but its onset is most frequent between the ages of 25 to 55; and

WHEREAS: Scleroderma is a very individualized disease and the symptoms range from very mild to lifethreatening; and

WHEREAS: Scleroderma can cause thickening and tightening of the skin, as well as serious damage to internal organs including the lungs, heart, kidneys, esophagus and gastrointestinal tract; and

WHEREAS: Prompt and proper diagnosis and treatment by qualified physicians can minimize the symptoms of Scleroderma and lessen the chance for irreversible damage, but there is not yet a cure for the disease; and

WHEREAS: There are five Scleroderma Foundation support groups in Ohio and the Scleroderma Foundation's mission is support, education and research to help find the cause of and cure for the disease.



AUTHORIZING THE CITY MANAGER TO ACCEPT THE FIRST TRANCHE OF THE AMERICAN RESCUE PLAN ACT OF 2021 (ARPA) FUNDS AND AFFIRM THAT SUCH FUNDS WILL BE EXPENDED ONLY TO COVER CITY OF KETTERING EXPENDITURES FOR ELIGIBLE USES CONSISTENT WITH THE REQUIREMENTS OF ARPA, SEC. 9901, PUBLIC LAW 117-2

WHEREAS, The American Rescue Plan Act of 2021, Public Law 117-2, (ARPA) was signed into law on March 11, 2021; and

WHEREAS, The ARPA provides additional relief to address the continued impact of COVID-19 on the economy, public heath, state and local governments, individuals, and businesses; and

WHEREAS, currently, the ARPA provides for the initial distribution in 2021 of 50% of the funds allocated to local governments with the remaining 50% to be distributed one year later;

NOW, THEREFORE, Be It Resolved by the Council of the City of Kettering, State of Ohio, that:

Section 1. The City Manager is hereby authorized, on behalf of the City of Kettering, to take all necessary and proper action to accept the above-described funds from the ARPA. Said funds will be expended only to cover City of Kettering expenditures for eligible uses consistent with the requirements of the ARPA, Sec. 9901, Public Law 117-2.

Planning Commission hereby certifies that a public hearing was held on June 7, 2021 with a decision reached at that meeting concerning a request for a street vacation at the NE Corner of Wilmington Pike and Brownleigh Rd.

Planning Commission hereby submits its recommendation to Council that the requested vacation be approved.

Vote of the Planning Commission

The motion recommending approval was passed by a unanimous vote of 3:0.

Planner's Notes

In anticipation of future street improvements and the sale of the parcel located at the northeast corner of Wilmington Pike and Brownleigh the City of Kettering wishes to vacate an approximate 7.5 foot by 69.5 foot portion of right-of-way which is not needed for street purposes. Staff is currently working with the owner of the adjacent parcel, 3122-3126 Wilmington Pike, to sell the city owner parcel. In preparation for this the city wishes to correct the right-of-way line making it consistent on the east side of Wilmington Pike. The sale of this parcel will be contingent on the dedication of right-of-way from the adjacent property to achieve the same consistency.
