


Gity of Kettering, Ohio – Government

REVENUE \$ IN MILLIONS




*2021 Budgeted Revenue of \$82.9 million










CITY OF KETTERING ANNUAL OPERATING EXPENDITURES







KETTERING IS A WONDERFUL PLACE TO START A NEW BUSINESS

Because income tax accounts for approximately 80% of the City's general fund revenue and the vast majority of our amenities and our valued city services are funded by income tax, we place a great deal of focus on attracting new businesses and on helping the businesses that are already in Kettering grow and thrive here. If we don't have the jobs, we don't have the resources to support the infrastructure, facilities and services our residents and businesses treasure. In the end, our goal is to protect the investment that you made when you decided to call Kettering home. That means that we invest in our commercial centers to support job growth, and we invest in our neighborhoods and world-class amenities.

KETTERING HEALTH OPENED NEW FACILITIES

On-Demand Care

Kettering Health opened a new On-Demand Care location in Kettering to give the community more access to walk-in primary care. The new location will be the fourth On-Demand Care location for the network. Located at 424 E. Stroop Rd., the one-story,



3,200 square foot building opened in early June. Some imaging services and treatment for minorillnesses and injuries,

including headaches, rashes, cough, and strains, will be available at the new location. This location will be the first health care

tenant at the Town and Country shopping center, which is owned by CASTO and Skilken|Gold.

The new location will employ six full-time positions and is a \$1.2 million investment in the community.

Years Ahead Health Center

Kettering Health opened a new Years Ahead Health Center in Kettering to give senior community members more access to health care services. The new location will be the second Years Ahead facility for the network.

Located at 1745 E. Stroop Rd., the one-story, 18,800 square foot building opened in late June and will feature patient-centered care with facility design and educational programs tailored for those 65 and older.

Services offered will include primary care, lab and imaging services and educational



and support programs

The new location will have a care team of eight medical providers, including physicians, advanced practice providers, behavioral health support specialists, and more than 20 support team staff members. The facility is a \$5.6 million investment in the community, continuing Kettering Health Network's commitment to providing high-quality care for local residents.



THE MIAMI VALLEY RESEARCH PARK

During 2020, Industrial Commercial Properties purchased four buildings and 28 acres of land at Miami Valley Research Park. Situated near Wright-Patterson Air Force Base, the developer views the properties as suitable to facilitate defense contractors and research users.

KETTERING POLICE DEPARTMENT RENOVATION

In 2019, we completed the design for a major renovation of the Kettering Police Department Headquarters within the Kettering Government Center complex. This \$8.8 million project brought the facility up to modern standards, improved and expanded the functionality of the existing space, expanded the operations of our Public Safety Dispatch Center, and created a new combined entrance for visitors to the Government Center North Building and Police Headquarters. Construction of the renovation project began in early 2020. Police personnel were moved to various locations throughout the City, and the Communications (Dispatch) Center was temporarily moved to Fire Headquarters. In September, the Chief of Police and administrative offices moved into the new upper level addition while renovations continued in the lower level. Patrol and detectives returned to headquarters in January 2021. Finally, Dispatch returned to their new work space, as well, and the renovation is complete.

WILMINGTON PIKE

The City of Kettering remains committed to acting as a catalyst for reinvestment along Wilmington Pike for both economic purposes and the impact the corridor has on our residents. The Wilmington Pike corridor is the backbone of our community, and its vitality is central to the strength of our commercial success. The Wilmington Pike Improvement Committee, a group of business owners and community stakeholders, engaged in a strategic planning process to identify the most important challenges and promising opportunities for this essential corridor. Together with City staff, they created a plan to regenerate investment and spur development. The Demolition Program provides financial assistance to commercial and residential property owners in the Wilmington Pike Demolition Program Designated Area

to assist in the demolition of structures and clearance of sites for redevelopment purposes. The Façade and Improvement Program allows businesses to apply for a grant up to \$25,000 to assist properties in the corridor with conforming to city code.

A current example of the benefits of these programs is Michael Cui's Restaurant. The restaurant will replace a former sports bar, vacant since 2009. The dining space at the former Norton's will be expanded by adding a 3,000 square foot patio The renovations will take place in 2021 bringing ten jobs to Kettering. Along with significant indoor renovations, the owner plans to add a new street façade with connections from city sidewalks to the property, as well as ambient outdoor features.

RIDGEWAY ROAD BRIDGE

The Ridgeway Road Bridge is also being replaced following significant public engagement efforts to collect feedback on project alternatives. City Council directed city administration to pursue grant funding for the purpose of reconstructing the bridge, and the Ohio Department of Transportation's Municipal Bridge Program granted the award. Construction began in late 2020. This project will also include an art installation to reflect the surrounding landscape of Hills and Dales Metro Park.

In 2020, Kettering Fire Department experienced a 90% reduction in its attendance of community activities. The community activities routinely attended by fire personnel had to be suspended in the name of safety. Fire Department personnel could no longer host station tours, attend ribbon cutting ceremonies or even visit the neighborhood block parties. This did not deter the Kettering Fire Department from educating residents about fire prevention. The KFD used other available methods of communication, such as social media, to disseminate important fire and life safety messages. Through Facebook and Twitter, KFD posted about firefighting operations in real-time. KFD also partnered with Miami Valley Communications Council (MVCC) to create an educational video for families to watch during National Fire Prevention Week.

All Kettering Fire Department (KFD) career firefighters are highly-trained paramedics and ready to respond to critically ill or injured patients 24 hours a day, 365 days a year. Every career Kettering firefighter is also required to be paramedic certified. Obtaining a paramedic certification is a time-consuming and process consisting of thousands of hours of intense coursework.

Tahjey resides in Kettering with his grandmother and grandfather, George and Tammy Lawson. Tahjey attends Kettering Middle School. His volunteer work is extensive and addresses many needs in our community spanning a variety of generations. His efforts include, serving the homeless by collecting coats and blankets (some of which he made); boxing personal care items for front line workers at local nursing homes and hospitals as well as hospitals and first responders in New York; collecting and donating baby items and diapers for Hannah's Treasure Chest; packing bags with hand sanitizer and snacks for the Kettering Police Department; creating and donating get well cards for those at the VA hospital; and he personally raised over \$1,000 for the PTA Walkathon at KMS which helped supply snacks during state testing. In addition, Tahjey served as Secretary to the Junior Optimist Club at KMS. Most recently, Tahjey was elected Governor of the Ohio District for Junior Optimist International. Tahjey's nominator stated, "Tahjey has had obstacles throughout his

life but he still finds the time to give to others. I cannot think of any other youth in our community who would be more deserving of this award."

Sue Solvig grew up in a military family which took her to California, Florida, Tennessee and Guam. She is married to her husband Bob and has two daughters, Erica and Rachel, and four grandsons. Sue and Bob spent several years in New York before making the move to our area in 2014.

Sue began volunteering for the City of Kettering in October, 2019. Until the pandemic, Sue's volunteer service included assisting at special events, receptionist's duties; helping with the nutrition program; and scheduling seniors rides as part of our senior transportation program at Lathrem Senior Center.

In March, 2020 the senior center closed due to the pandemic. During this time Sue and other volunteers rose to the challenge by making phone calls to isolated seniors to ensure their wellbeing. As the pandemic continued, Sue offered to return to help with the senior transportation program.

After making some safety modifications to the office area, she returned in July to assist with this essential program. Typically, the center enlists the help of five volunteers, one each day from 8 – noon. Sue stepped up to help every day from 8 – 10 a.m.

Sue's nominator had this to say, "One of the most amazing things about Sue is her ability to truly bond with the clients, listen to them and make them feel safe. She spends hours on the phone talking through pandemic related fears and other issues regarding isolation. She also talks with family members regarding their loved one's transportation needs. She clearly and patiently explains our program to new clients. She is so well liked that many callers are disappointed when a staff member answers the phone—they want to talk with Sue!"

Her nominator also explained, "Sue is gifted with a servant's heart. With the changes thrust upon us at the onset of the pandemic, she did not hesitate to offer help, demonstrating what "community" is all about!"
