POLICE BLOTTER

Monday July 19, 2021

- 1355hrs Officers responded to meet a Sugarcreek PD officer on a warrant detail. Upon his arrival he took custody of **Anthony W. Callahan, w/m/46**, on a KPD original assault warrant. **21-030188**
