# KETTERING CITY COUNCIL REGULAR MEETING MINUTES July 27, 2021

The Council of the City of Kettering, Ohio, met in regular session on Tuesday, July 27, 2021, at 7:30 p.m. in Council Chambers at the Kettering Government Center South Building, 3600 Shroyer Road. Mayor Patterson presided and the Clerk of Council, LaShaunah D. Kaczynski, recorded. This meeting was telecast live on the cable access channel and streamed live at mvcc.net.

## PUBLIC COMMENT ON LEGISLATION

Sterling Abernathy- Mr. Abernathy mentioned he has comments this evening regarding agenda items two and eight resolutions to increase budget spending in 2021 for the Rosewood Arts Centre Renovation Project. The amount of this year's increase is \$708,000 which is a 42% increase. The resolution includes a reason for the increase which stated it was necessary to include in the first phase work that was scheduled to be done in future phases. Renovation to the main restroom and the fire alarm system resulted in a cost increase for the first phase. Work that has been planned for future years has moved forward to this year. City records indicate that the total cost for the work being moved to this year totals \$340,000. That is a lot less compared to the \$708,000 increase associated with this resolution. The reasons stated in the resolution are misleading at best and deceptive at worst. The resolution should be corrected before City Council takes action on this legislation or better yet reduce the scope of the project to save money instead of automatically approving cost increases. This project is budgeted for over four years, starting with the design cost in 2020 plus three more years of construction. In January 2020, City Council was told that the total project cost was \$5 million. Of that cost, \$4.3 million was to be used for design and construction and \$700,000 was to be used for furniture, fixtures and equipment. Two weeks ago at the City Council workshop meeting, he learned that the total cost of this project for all years is now \$6.4 million. The increase from \$5 million to \$6.4 million is due to additional construction cost of \$873,000 and an increase of furniture, fixtures and equipment costs of \$500,000. Even after reductions including a grant from the state and private donations, Kettering tax payers will still be on the hook for \$4.7 million for the Rosewood project. This is a large amount considering half the people who use Rosewood do not live, work or pay taxes in Kettering. The \$4.7 million is an overall cost increase of \$873,000 for Kettering tax payers which is a 23% increase in 18 months since City Council first approved design spending. These increases come before construction has even started. He knows from history of city projects that the cost of this project is likely to increase even more once completed. In summary, City Council should include the real reason for the 2021 spending increase in the resolution that is presented this evening. Second, City Council should stop increasing millions of dollars Kettering tax payers are paying to renovate an arts facility that half the people who use it do not live, work or pay taxes in Kettering. Mr. Abernathy presented a handout to City Council of a summary of cost increases for the Rosewood project.
