# KETTERING CITY COUNCIL REGULAR MEETING MINUTES November 9, 2021

The Council of the City of Kettering, Ohio, met in regular session on Tuesday, November 9, 2021, at 7:30 p.m. in Council Chambers at the Kettering Government Center South Building, 3600 Shroyer Road. Mayor Patterson presided and the Clerk of Council, LaShaunah D. Kaczynski, recorded. This meeting was telecast live on the cable access channel and streamed live at mvcc.net.

Mayor Patterson led the audience in the Pledge of Allegiance and gave the invocation. He introduced the Miami Valley Communications Council TV Operator Mike Sopronyi. He thanked him for his assistance.

# **APPROVAL OF MINUTES**

October 26, 2021- Council Meeting & Workshop Minutes

Mr. Lautar reported that he reviewed the above minutes and moved the minutes be approved. Mrs. Fisher seconded the motion of the above minutes and there being five (5) yea votes and no (0) nay votes for October 26, 2021 Council Meeting & Workshop Minutes, the motion was declared carried followed by a roll call vote.

## **PUBLIC HEARINGS**

## PUBLIC COMMENT ON LEGISLATION

Todd Elzey- 3779 Waterbury Drive- He is here this evening in regards to item ten on the agenda concerning a proposed ordinance to permit shared mobility devices such as e-scooters and bikes within the City of Kettering. He is asking that City Council rejects the proposed ordinances as written due to safety concerns for Kettering residents who are blind or who may have other disabilities. The National Federation of the Blind Ohio passed a resolution in 2019 regarding shared mobility devices and he has provided a copy of that resolution to the City Manager, Mayor and each member of City Council prior to the meeting this evening. He has four concerns with the proposed ordinance as it is written. Mr. Elzey expressed his concern regarding the narrow sidewalks in Kettering. These devices especially if there are racks included often obstruct the path of travel. This obstruction is troublesome for blind pedestrians and this could also be troublesome to pedestrians in wheelchairs and other mobility assistive devices. In addition, the proposed ordinance as written permits racks to be placed on private property. Private property owners often obstruct the ADA path of travel for disabled patrons, and he has seen these devices further encroach on that path of travel. Another concern of this proposed ordinance as written is the permitted use of dockless devices. Shared mobility devices could have the potential to be left all over town including be unattended on sidewalks for long periods of time. This could be troublesome for a person with a disability because there would be no warning that they are approaching this discarded device, resulting in the pedestrian either to find a way to go around them or move them out of their way. The ordinance does call for companies to place information on the scooters on how to report a complaint. He has found that most companies do not place that information on scooters in a format that a blind or visually impaired individual can access. In addition, most companies call for complaints to be filed via mobile apps or website apps, and those apps are almost 100% across the board inaccessible to a blind individual using screen reader software. This can easily become a situation where a blind individual doesn't know to whom the scooter belongs to that is in their way and to complain about, and they can't even file the complaint due to inaccessible processes. Under the proposed ordinance, scooters can be used starting at 8:00 a.m. and the owners of the scooters do not have to move scooters that were left in the wrong places until 9:00 p.m. That leaves a way for these devices to be out in the way of disabled pedestrians for up to 13 hours. His biggest concern is regarding the safety of these devices. These devices are particularly quiet because most shared mobility devices are electric. This takes away the ability of a blind or a hearing impaired pedestrian to protect their own safety because they are unable to hear these devices approaching. This ordinances calls for individuals who are operating these devices to call out when they are about to pass someone, but most individuals do not routinely do that. They either don't read the instructions on how to properly operate the device or they forget when they are

operating the scooter. This results in the person who is operating the scooter to go quickly by a person with a disability. For a person who has hearing loss, a single call out to a person while they are operating the scooter is useless because they are unable to tell the direction in which these devices are coming from by a single call out. For these reasons, he is asking that City Council rejects this ordinance as it stands right now and he encourages City Council to consider rewriting this ordinance so there are greater ADA protections for pedestrians with disabilities.

Mr. Schwieterman thanked Mr. Elzey for his comments and he informed City Council that city staff would be happy to meet with Mr. Elzey to address some of his concerns with the interpretation of the ordinance as it is currently written or what possible changes might be necessary to the ordinance. The ordinance is in first reading this evening, if there are changes to the ordinance due to material changes, the ordinance can be brought back in first reading with those changes. If some changes are not reaching the level of materiality but still need to be corrected, city staff can make those changes and bring them forward in second reading of this ordinance which is scheduled for the next City Council meeting. City staff will meet with Mr. Elzey to review his comments and see if there are ways to make improvements to this ordinance or explain the ordinance in better detail.
