## POLICE BLOTTER

**Monday November 15, 2021**

- 0850 hrs      Officers were dispatched to 2111 W Bataan to assist Greene County Probation in attempting to locate a male who had warrants. While he did not locate the male, **Leah Darrah W/F/49** was located at the residence and found to also have several warrants from Richland County SO, Xenia PD, and Beavercreek PD.
