### Proclamation- Lung Cancer Awareness Month

Mr. Lautar read the above proclamation and same was accepted by Lisa Moran, Kettering resident. Ms. Moran thanked Mayor Patterson and City Council for recognizing the importance of Lung Cancer Awareness Month. Ms. Moran mentioned she is a Might Oak, Knight, Firebird, daughter, sister, girlfriend, niece, cousin and also known as Auntie Lisa to her best friend children. After living out of state for 22 years, she returned to Kettering in October 2021. She is a proud Kettering resident. Her connection to lung cancer is very personal. In August 2015, at the age of 44, Ms. Moran went from starting a career as a city mail courier, going to the gym after work and living an athletic and healthy life style with no tobacco use to being diagnosed with stage four non-small cell lung cancer. At the time of her diagnosis, the cancer had spread to both of her lungs and to her spine. The only symptoms she had experienced were an intermittent persistent cough and pain in her foot. The late stage diagnosis is not uncommon. Lung cancer is easily mistaken for other illnesses and her cancer was first misdiagnosed as a virus, post-nasal drip and plantar fasciitis. Lung cancer is the #1 cancer killer in the United States and worldwide. The more people are aware and educated about the disease, the more they will support those individuals living with lung cancer and fund research and development of new lung care cancer treatments. Lung cancer research, awareness and development of new treatment options are vital to all lung cancer patients. She is aware that lung cancer research is the reason why she is speaking today. She was told she only had a 3-5% chance to live one year after diagnosis. She is beating those odds every day. Two of the seven drug treatments that are specific to the mutation that drives her lung cancer were FDA approved after her 2015 diagnosis. The White Ribbon Project that was started in Colorado in 2020 is now a grass roots

movement for lung cancer survivors and caregivers to help promote awareness about lung cancer by changing the public perception of the disease. Anyone with lungs can get lung cancer.

Ms. Moran asked Mayor Patterson to join her in signing the white ribbon and writing an encouraging message on the ribbon.

Mayor Patterson thanked Ms. Moran and wished her continued success on her journey.
