POLICE BLOTTER

Monday January 10, 2022

- 0845 hrs Officers were dispatched to 4370 Flowerdale on a family problem. The caller stated she had been assaulted by her adult son, **Ian Stevens W/M/36**. Investigation revealed that he had struck his mother and Stevens was arrested and transported to jail without incident. **21-001386**
