POLICE BLOTTER

Monday January 24, 2022

- 1712 hrs Officers initiated a stop at S. Smithville/Moler for traffic violations. Contact was made with the driver who had an entered warrant through Moraine PD. **Kevin L. Jones B/M/22** was arrested on his warrant and transported to the Kettering Jail. **22-003749**
- 2036hr Officers stopped a vehicle on Fairway at W. Dorothy for a moving violation. During the stop the strong odor of marijuana was found to be coming from the vehicle. During a pat down of the front seat passenger a loaded 9mm handgun was found in his pants pocket as well as one in a bag in the car. **Telvin Armstead, b/m/31**, was arrested for CCW and improper handling of a firearm in a motor vehicle.
