# KETTERING CITY COUNCIL REGULAR MEETING MINUTES December 14, 2021

The Council of the City of Kettering, Ohio, met in regular session on Tuesday, December 14, 2021, at 7:30 p.m. in Council Chambers at the Kettering Government Center South Building, 3600 Shroyer Road. Mayor Patterson presided and the Clerk of Council, LaShaunah D. Kaczynski, recorded. This meeting was telecast live on the cable access channel and streamed live at mvcc.net.

# Special Presentation- Remarks from Mayor Patterson

Mayor Patterson mentioned one of his duties as Mayor is that he has the privilege to recognize individuals within the community that have gone above and beyond what is expected of a traditional resident. During his tenure as Mayor, he has only given out two Keys to the City. He doesn't take this lightly and individuals who are recipients of this honor have gone above and beyond for the Kettering community. This evening he will be presenting five Keys to the City.

Mayor Patterson expressed the first recipient is a couple who have been unbelievable workers within the Kettering community. They are involved in the Holiday at Home Parade, Christmas Day at Polen Farm and they host the best block party within the city. It was at their block party that he received his first proclamation as Mayor. Also, at this couple's block party last year, he received a signed rock from the neighbors and his own box of Esther Price chocolates. Mayor Patterson thanked Bill and Marynel Bradley for their years of service to the Kettering community. Mayor Patterson presented Bill Bradley with a Key to the City.

Mayor Patterson mentioned the next recipient is an individual he has served alongside over the past eight years and he has been honored this evening for his public service. Bill Lautar is the retired Director of Student Services for the Kettering School District and he received his bachelor's degree from Ohio University and his master's degree from the University of Dayton. Mr. Lautar has been a Kettering resident for over 50 years. City Council is unique due to the various backgrounds of each member. Mr. Lautar brought a school background and City Council looked to his leadership when it came to making decisions on how to better serve the youth within the community. Mayor Patterson appreciates the friendship he has developed with Mr. Lautar during his time on City Council. Mayor Patterson presented Bill Lautar with a Key to the City for his dedication to the Kettering community.

Mayor Patterson highlighted Bruce Duke is the next Key to the City recipient. Mr. Duke has served on City Council since December 1, 1986. Mr. Duke is the retired Assistant Director of Counseling Services for the University of Dayton. He has a PhD in counseling from the Ohio State University and has been a resident of Kettering for 46 years. Mr. Duke was the only current member of City Council that was serving when he began his public service tenure. Over the years, Mayor Patterson and Mr. Duke have developed a friendship and they have enjoyed reminiscing about the city over the years. At one point in time, Mayor Patterson and Mr. Duke ran against each other for the mayor position. In today's environment, you would think this would make you enemies for life, but they maintained their friendship and their friendship grew stronger. Mayor Patterson thanked Mr. Duke for all of his years of public service and for everything he has done for the residents of District 4 and for everything he has

done for the Kettering community as a whole. Even after 46 years, Mr. Duke still has a deep passion to serve the Kettering community. Mayor Patterson presented Mr. Duke with a Key to the City.

Mayor Patterson expressed he would like to present Walter A. (Tony) Klepacz as the next Key to the City recipient. Mr. Klepacz is currently serving as Vice Mayor and has served on City Council since February 2007. Mr. Klepacz retired from NCR Corporation and is a graduate of Sinclair and Capital University. Mr. Klepacz has been a resident of Kettering for 26 years and Mr. Klepacz has served as Mayor Patterson's confidant while on City Council. Mr. Klepacz was his go-to person no matter the problem. If he had a question or needed a pat on the back he would turn to Mr. Klepacz. Mr. Klepacz is a true friend, and it has been a wonderful relationship. He is pleased and honored to present this award to his friend. Mayor Patterson presented Mr. Klepacz with a Key to the City.

Mayor Patterson mentioned the final recipient he would like to present a Key to the City is Mark Schwieterman, City Manager. Mr. Schwieterman has been with the City of Kettering since 1989. He became the Assistant City Manager in 2000 and the City Manager in 2006 which is the same year Mayor Patterson was elected Mayor. Mr. Schwieterman received his bachelor's degree in business administration and his master's degree public administration both from the University of Dayton. He and Mr. Schwieterman didn't always agree but they would find solutions and common areas to make Kettering a better community. All of his accomplishments would have not been possible without the leadership of the City Manager. Mr. Schwieterman loves the Kettering community and he works to make things better. All members on City Council are better individuals due to Mr. Schwieterman leadership. He has enjoyed serving as Mayor for the past sixteen years because Mr. Schwieterman had the same vision he shared to make Kettering a better place which he and Mr. Schwieterman have accomplished together.
