### Monday January 31, 2022

- 1533hrs Officers were sent to 1769 Utica on a peace officer call. During the call they found that **Larrick Buchholz, w/m/22**, had a no contact order with one of the subjects at the residence. Buchholz was arrested and transported to KPD jail. 22-004968
- 1600 hrs Officers conducted a traffic stop on Vale near Galewood for a moving violation. The driver of the vehicle was identified as **David A. Kovacs (W/M/35)**.
