POLICE BLOTTER

Monday February 28, 2022

- 1317 hrs. Officers responded to Miami Valley Hospital on a warrant service. Once there, the warrant was amended to a summons by Judge Long and **Nicholas M. Haywood (W/M/40)** was served with a new court date. The original warrant was for Trespass. **20-016574**
- 1847 hrs. A citizen called to report arriving home and finding someone sitting in her vehicle that was parked in the driveway. After startling the subject he walked off and began knocking on a neighbor's door. The male was located by officers in the area of E. Dorothy Ln. and Oakmont. **Jose A. Ayala (H/M/41)** was positively identified as the suspect and arrested for Criminal Mischief and Unauthorized Use of MV. He was transported to the KPD Jail where he was incarcerated. **22-009528**
