POLICE BLOTTER

Monday March 21, 2022

- 1102 hrs. Crews went to 205 Henrich on a family problem. Adult daughter, **Heather S. Lowry (W/F/37)**, had made threats to kill her mother. Ms. Lowry was arrested for DV/Threats and taken to Mont. Co. Jail. **22-012970**
