### Monday March 7, 2022

- 1555 hrs. Officers stopped a car in the 2100 block of Patterson Rd. for moving and equipment violations. The driver, **Edith L. Philbeck (W/F/36)**, was DUS X3 and had a Dayton warrant for FTA/DUS. She was arrested on the warrant and transported to the Kettering Jail. **22-0010732**
- 2250 hrs Officers initiated a traffic stop at S. Dixie/Hoyle for traffic violations. Contact was made with the occupants who appeared nervous and suspected narcotics were observed in plain view. During a search of the vehicle, two baggies of cocaine were located along with methamphetamine, heroin, marijuana and several crack pipes. **Anthony L Davis B/M/52** and **Sonae Y.
