### Monday April 25, 2022

0057 hrs Officers responded to 2111 W. Bataan on a warrant service. On arrival, contact was made with the subject who retreated into his house. Crews responded to assist and entry was made. **Joseph F. Darrah W/M/52** was arrested on a warrant through Xenia PD for Agg. Robbery (F) and a Probation Violation (F) through Richland County. **Leah R. Darrah W/F/49** was found hiding in the basement was arrested on a warrant through Greene County S.O. for Hit/Skip and was charged with Obstructing Official Business. **22-018841**
