POLICE BLOTTER

Monday May 23, 2022

- 1115 hrs. Officers responded to CVS (1410 E. Dorothy Ln) on a welfare check. Upon arrival he located **Mindy J. Williams (W/F/60)**, intoxicated and unable to care for herself. She was transported to KPD Jail where she was incarcerated. She was released after a brief period of time and she was again located on Wilmington Pk making suicidal comments. She was then transported to Miami Valley South for a mental health evaluation. **22-023358**
- 2230 hrs. Officers conducted a traffic stop in the area of S. Dixie and W. Dorothy for a registration violation. A passenger in the vehicle was identified as **Serenity S. Drake (W/F/49)** and was discovered to have a felony warrant through MCSO for FTA- Poss. of Cocaine. The warrant was confirmed and she was taken into custody and transported to the Mont. Co.
