POLICE BLOTTER

Monday July 4, 2022

- 1822 hrs Officers initiated a traffic stop on a suspect from a theft complaint he was working in the 5600 blk E. Coach Drive. After consent was gained to search the vehicle, suspected cocaine and drug paraphernalia were located. **Jenny T. Truong (A/F/24)** was arrested for Possession of Drugs (F) and Drug Paraphernalia. **22-030383**
