## KETTERING CITY COUNCIL REGULAR MEETING MINUTES August 23, 2022

The Council of the City of Kettering, Ohio, met in regular session on Tuesday, August 23, 2022, at 7:30 p.m. in Council Chambers at the Kettering Government Center South Building, 3600 Shroyer Road. Mayor Lehner presided and the Clerk of Council, LaShaunah D. Kaczynski, recorded. This meeting was telecast live on the cable access channel and streamed live at mvcc.net.

Mayor Lehner led the audience in the Pledge of Allegiance and gave the invocation.

Mayor Lehner welcomed Tia Payne, Founder of Girls Emerging into Maturity and Ms. Payne's mentees to the City Council meeting.

Mayor Lehner introduced the Miami Valley Communications Council TV Operator Mike Sopronyi. She thanked him for his assistance.

Audience Participation (5 Minute Limit per Speaker)

John Biller- 1308 Elmdale Drive- Mr. Biller thanked Mayor Lehner and City Council for his opportunity to speak this evening. Mr. Biller also expressed it is good to see members of the community present this evening at the City Council meeting. He would like to bring to the City Council's attention opportunities for success he has compiled from the residents of Berkeley Heights in District 4. The mosquito population has made their backyards and front porches unbearable during the nicest weather of the year. As a resident, Mr. Biller can attest to the validity of this concern. Within minutes of being outside on his front porch, residents are swarmed by mosquitoes. Is there anything that the City Council can do to increase the quality of life of the residents who are affected? The next opportunity that has been brought to Mr. Biller's attention is the concern regarding traffic patterns along Regent Street and Hilton Drive. Residents are specifically concerned about speeding vehicles and impaired drivers. Residents of this neighborhood seem to be split regarding the best course of action since speed bumps are not an option. Increased speeding tickets may alleviate the situation, however Mr. Biller can't entirely agree with this notion but he does have a few recommendations. A speed limit sign is needed for Regent Street as it appears one was not placed back after a recent construction project and a radar speed limit sign for Hilton Drive will solve the speed issue at that location. In addition to those two items, Mr. Biller believes the City of Kettering should engage in a conversation with the City of Dayton since they own the golf facility. There is enough space on the property for a driveway that would alleviate the through traffic in the neighborhood. This is the only practical solution to the concern that the residents have. The neighborhood demographics are shifting back to younger families with small children who are drawn to Southdale Elementary School. Since the golf course serves alcohol, there may be some patrons that will leave the golf course slightly impaired. Combine that with physical exertion that is a recipe for a traffic accident in the community. Mr. Biller recognizes this is a costly project and the City of Dayton would likely not want to fund this proposal, but perhaps the City of Kettering could purchase the property from the City of Dayton and invest the money into the community by adding an additional revenue stream. The last opportunity he would like to highlight this evening is there seems to be a misunderstanding between African American community members and the police department. Mr. Biller would like for the police department to arrange a community event at the Hills and Dales Park as a way to get to know the community and a way to break down racial barriers. Mr. Biller expressed this is a difficult conversation to start, so he would like to volunteer himself to serve as a liaison for the community to begin the conversation.

Mayor Lehner thanked Mr. Biller for his comments this evening. Several issues he raised deal with the police department and Chief Protsman is available for a conversation. Mayor Lehner asked Mr. Bergstresser to elaborate regarding the city's policy for spraying for mosquitoes.

Mr. Bergstresser mentioned there are some communities that actively engage in aerial mosquito spraying. This is something the city is currently not actively participating in. City staff can look further into this suggestion, but currently the city does not have an active mosquito spraying program.

Mr. Duke expressed over the years, there have been concerns periodically with patrons leaving the golf course that are inebriated. The city has worked effectively with the golf course management over time, so that suggestion is something the city can engage in by talking to the course administrators. The course administrators work closely with the golf leagues to limit that issue. Mr. Duke thanked Mr. Biller for bring that matter to his attention this evening. The speeding and the alcohol once a patron leaves the golf course is a matter the city can look into. The City of Kettering will not be able to purchase the golf course from the City of Dayton because that land is in perpetuity to the City of Dayton from John Patterson. The city can work on the other issues to help create a better living environment for the residents of that neighborhood.
