POLICE BLOTTER

Monday January 16, 2023

Ultimately, it was determined that **Mallory L. Black w/f/31** and another male, Steven Johnson, overdosed on narcotics. Black became unconscious in the parked car while Black made it to the apartment and then went unconscious. Black was issued a summons for Disorderly Conduct Public Intox.
