POLICE BLOTTER

Monday January 9, 2023

- 0726 hrs Officers were sent to the Meijer on Springboro Pike where they met an MCSO deputy for a warrant service. Upon arrival he took custody of **Andrew J. Snodgrass WM/45**, who was wanted on our active warrant (original charge discharging a firearm with the city limits) and transported him directly to the KMC. He was released into the custody of the CSO's. **23-001244**
- 1020 hrs Officers went to Warehouse 4 on a trespassing complaint. **Rhobyn I. Waggoner BM/45**, who had been previously trespassed from the store, quickly left. There was video evidence of him at the store so officers went to his residence, where he found Waggoner in the exact same clothes as in the video. Waggoner was arrested for criminal trespassing. **23-001282**
- 1148 hrs Officers stopped a vehicle for a traffic violation near Sacramento and S. Dixie. The driver, **Samson Jano BM/24**, had an active warrant out of OSP (original charge FTA-DUS) who he was arrested and transported to the jail without incident. **23-001297**
