POLICE BLOTTER

Monday February 13, 2023

- 1423 hrs Officers responded to Patterson Blvd on a welfare check where he found a **(W/M/40)** deceased from an apparent self-inflicted gunshot wound. The scene and investigation were turned over to the detective unit. **23-006807**
- 1732 hrs Multiple crews responded to the area of the bus stop on Cardington Rd. behind Wal-Mart on a weapons complaint. Investigation revealed a female, **Vallene Jones (B/F/29)** brandished a firearm toward another female, **Denean Wallace (B/F/51)** then left the scene to Capri Lanes where she was located in the restroom. Jones was located, arrested, and charged with Obstructing Official Business and CCW. Wallace was placed under arrest for a warrant through Moraine P.D. and issued a summons for Obstructing Official Business. **23-006856**
