POLICE BLOTTER

Monday February 27, 2023

- 1218 hrs Officers initiated a traffic stop for violations on Montgomery Square Drive. The driver, **Samuel Musore (B/M/22)** was arrested on warrant for FTA through the Mercer County SO. **23-009071**
