### Monday March 13, 2023

2225 hrs. Officers initiated a traffic stop on a vehicle for illegal window tint. During contact with the driver, **Cameron J. Harnish was arrested and charged with the license suspension and drug paraphernalia.

### Tuesday March 14, 2023
