KETTERING CITY COUNCIL REGULAR MEETING MINUTES May 9, 2023

The Council of the City of Kettering, Ohio, met in regular session on Tuesday, May 9, 2023, at 7:30 p.m. in Council Chambers at the Kettering Government Center South Building, 3600 Shroyer Road. Mayor Lehner presided and the Clerk of Council, LaShaunah D. Kaczynski, recorded. This meeting was telecast live on the cable access channel and streamed live at mvcc.net.

Mayor Lehner expressed in honor of Police Memorial Week the Kettering Police Department Color Guard will be presenting the Colors this evening.

Mayor Lehner led the audience in the Pledge of Allegiance and gave the invocation.

Mayor Lehner introduced the Miami Valley Communications Council TV Operator Mike Sopronyi. She thanked him for his assistance.

Mayor Lehner mentioned Mr. Duke have excused absence.

Mayor Lehner read a brief message from Mr. Duke. He has recovered to the point he is able to write a message. Mr. Duke's message explained he has missed a number of meetings since January. He is in the hospital recovering from HSV-1 and this virus has attacked his brain and it has damaged the left side of his brain causing some memory loss. The inactivity has caused the inability to use the majority of his muscles which he is working with rehab to recover from. In the months of January and February he was in a coma trying to fight the virus and since then he has been in the hospital recovering. He wanted to let residents know of the severity of this illness and to also apologize that he has not been able to participate in the activities in the community. He is thankful for all of the warm wishes, visits, cards and prayers.

Mayor Lehner expressed Mr. Duke wasn't able to talk a month ago and now he is able to dictate a message and she believes Mr. Duke will be back.
