POLICE BLOTTER

July 17, 2023

0933 hrs Officers stopped a vehicle on Wilmington Pike near Devon for a registration violation. A passenger in the vehicle, **David R. Sohn (WM/57)** had an active warrant out of the MCSO, original charge DV, so he was arrested. **23-031957**
