POLICE BLOTTER

Monday August 7, 2023

- 1006 hrs Officers responded to 1541 Constance Avenue for a theft report. During the course of the investigation, stolen property was recovered and a suspect was identified. A signed affidavit for theft was completed for **Lori A. Richards (W/F/39)**, who remained at large at the time of this report. **23-035154**
