WHEREAS: Educating all members of the Kettering community about the importance of conservation will continue to improve the quality of life for all residents in the community.



AUTHORIZING COMPLETION OF OHIO DEPARTMENT OF TRANSPORTATION ("ODOT") PROJECT MOT-SR 48/835-6.49/1.47, PID 111570, WITHIN THE CITY OF KETTERING AND AUTHORIZING THE CITY MANAGER TO ENTER INTO ONE OR MORE RELATED CONTRACTS WITH ODOT; AND TO RESCIND RESOLUTION 10908-23

WHEREAS, ODOT has determined the need for mill and fill with asphalt concrete on State Route 48, Straight Line Mile 6.49 to 6.95, more or less and State Route 835, Straight Line Mile 1.47 to 2.73, more or less, within the City of Kettering, Montgomery County, Ohio, ODOT Project MOT-SR 48/835-6.49/1.47, PID 111570 (the "Project"); and

WHEREAS, previously, the SR-48 and SR-835 roadway segments were separate projects but ODOT combined them into one project; and

WHEREAS, on May 23,2023, before the projects were combined, Council passed Resolution No. 10908-23 authorizing completion of ODOT Project MOT-48-6.49, PID 111571, within the City of Kettering and authorizing the City Manager to enter into one or more related contracts with ODOT;

NOW, THEREFORE, Be It Resolved by the Council of the City of Kettering, State of Ohio, that:

<u>Section 1</u>. Council finds that the Project is in the public interest and gives consent to ODOT to complete the Project. The City Manager is authorized to cooperate with ODOT in execution of the Project.

Section 2. In relation to the Project:

The City agrees to participate in the cost of the Project;

The City further agrees to pay 100% of the cost of those features requested by the City which are determined by the State and Federal Highway Administration to be unnecessary for the Project;

The City further agrees that change orders and extra work contracts required to fulfill the construction contracts shall be processed as needed. ODOT shall not approve a change order or extra work contract until it first gives notice, in writing, to the City. The City shall contribute its share of the cost of these items in accordance with other sections herein; and

The City further agrees to pay 100% of the cost to install and/or repair curb ramps at all necessary intersections to ensure compliance with the Americans with Disabilities Act.

Section 3. The City Manager is authorized to enter into and execute contracts with ODOT which are necessary to develop plans for and to complete the Project; and to execute contracts with ODOT pre-qualified consultants for the preliminary engineering phase of the Project. The City Manager is further authorized to sign any amendments or extensions thereto that the City Manager deems appropriate.

Upon request of ODOT, the City Manager is also authorized to execute any appropriate documents to affect the assignment of all rights, title, and interest of the City to ODOT arising from any agreement with its consultant in order to allow ODOT to direct

additional or corrective work, recover damages due to errors or omissions, and to exercise all other contractual rights and remedies afforded by law or equity.

Section 4. The City agrees that all right-of-way required for the described Project will be acquired and/or made available in accordance with current State and Federal regulations. The City also understands that right-of-way costs include eligible utility costs.

The City further agrees that all utility accommodation, relocation and reimbursement for the Project, if any, will comply with the current provisions of 23 CFR 645 and the ODOT Utilities Manual.

Section 5. Upon completion of the Project, and unless otherwise agreed, the City will: (1) provide adequate maintenance for the Project in accordance with all applicable State and Federal law, including, but not limited to, Title 23, U.S.C., Section 116; (2) provide ample financial provisions, as necessary, for the maintenance of the Project; (3) maintain the right-of-way, keeping it free of obstructions; and (4) hold said right-of-way inviolate for public highway purposes.

Section 6. Resolution No. 10908-23 is rescinded.

<u>Section 7</u>. As provided in Section 4-8 of the City Charter, this Resolution takes effect immediately upon its adoption.

TO REZONE 4225 AND 4235 WILMINGTON PIKE FROM R-1 SUBURBAN RESIDENCE, R-4 VILLAGE RESIDENCE, AND BP BUSINESS PARK DISTRICTS TO R-4 VILLAGE RESIDENCE DISTRICT (PLANNING COMMISSION CASE NO. PC 23-014)

WHEREAS, on July 17, 2023 after publication and issuance of notice as required by the City of Kettering Zoning Code, a public hearing was conducted by the City of Kettering Planning Commission concerning an application to rezone land located at 4225 and 4235 Wilmington Pike (Montgomery County Auditor's Parcel Nos. N64 03404 0041, N64 03404 0058, N64 03404 0124, N64 02212 0010, N64 02212 0011, and N64 02212 0024) (the "Properties") to R-4 Village Residence District; and

WHEREAS, the Planning Commission recommended approval of the proposed zoning change; and

WHEREAS, on August 8, 2023, after publication and issuance of notice as required by the Zoning Code, this City Council held a public hearing with evidence presented by the Planning and Development Department along with the recommendation of the Planning Commission to approve the application, and all parties were afforded the opportunity to be heard and present evidence in support of their positions;

NOW, THEREFORE, Be It Ordained by the Council of the City of Kettering, Ohio, that:

Section 1. Having considered the staff report(s) and recommendation of the Planning Commission, the criteria set forth in Sections 1153.12.9, Consistency, through 1153.12.15, Other Factors, of Chapter 1153 of the Zoning Code, the testimony and evidence presented at the public hearing, sound planning and zoning practices, the City's adopted plans, goals, and policies, the intent of the Kettering Zoning Code, and the public health, safety and welfare requirements underlying the Zoning Code, City Council finds that the application for rezoning should be approved.

Section 2. Based on the foregoing, the Property is rezoned from R-1 Suburban Residence, R-4 Village Residence, and BP Business Park Districts to R-4 Village Residence District.

Section 3. As appropriate and necessary, the official Zoning Map of the City of Kettering, Ohio is hereby revised and amended to reflect the zone change(s) referred to in Section 2 above; and Section 1133.02 of the Kettering Codified Ordinances, which adopts the Zoning Map by reference, is hereby reenacted effective as of the first effective date of this Ordinance so as to include the map revision in the Zoning Code. The Director of the Planning and Development Department is directed to make such appropriate revisions on the official Zoning Map of the City.

Section 4. As provided in Section 4-8 of the City Charter, this Ordinance shall be effective two weeks after adoption.
