Mrs. Schrimpf informed City Council information will be placed on the city's website once it has been certified by the Ohio Department of Development and there will also be a community meeting which will allow residents to talk to the city's housing officer and other staff about how this project will work.

Mayor Lehner clarified that the project is within a set neighborhood in the community.

Mrs. Schrimpf informed City Council that this project is within a certain neighborhood and there are borders that the city has to adhere to.

Mr. Greeson informed City Council that the community meeting will also be an opportunity to highlight other housing programs that are offered through the city that residents may not be familiar with and if they are not able to use the Community Reinvestment Area program, they may qualify for a different housing program.

Audience Participation (5 Minute Limit per Speaker)

Joe Overholser- 2924 Acorn Drive- Mr. Overholser expressed he is a candidate for City Council for District 1 and he would like to bring up a few reasons why is running for City Council. One reason he is running for City Council is the issue with communicating with residents regarding housing developments, particularly the development behind Meijer. There wasn't good outreach to the community and he recently had a meeting with some local real estate investors and to this day, they don't have a lot of information regarding what type of housing it is. Mr. Overholser believes it is income restricted housing and he believes there needs to be better communication. Mr. Overholser expressed he would also like to address, which is also related to housing, an exhibit that the Kettering

Board of Community Relations put on several months ago at Fairmont High School titled Undesign the Redline. This is a very divisive concept that the city should not be involved with and especially at the high school. He believes the exhibit has critical race theory concepts behind it and having this exhibit at the school is not a good idea being it's a controversial topic. He feels like it's kind of underhanded as well...

Mayor Lehner informed Mr. Overholser that this point in the program is not to give a campaign speech and she has let him go further than what she probably ought to and this procedure will be the same for any candidate who would like to speak. Mayor Lehner informed Mr. Overholser if he has additional items that he would like to talk about that are not related to the campaign or a campaign platform....

Mr. Overholser expressed he is still a citizen and it's not a campaign speech and these are concerns that he has.

Mayor Lehner asked that Mr. Overholser frame his comments as concerns.

Mr. Overholser expressed he feels that he is entitled to his five minutes to speak about his concerns and the fact that he is a candidate for City Council doesn't mean he doesn't have a right to speak about these items. The exhibit has to do with making housing more affordable and there are great programs for that. He was happy to hear about the housing rehabilitation program that has been expanded and he personally would expand that program more. There are a lot of ways to help people in need without being divisive and boards that are associated with Kettering should not be involved with that.
