POLICE BLOTTER

December 18, 2023

- 1029 hrs Officers responded to 3100 Valleywood Dr for a theft report. The business owner reported a theft of a catalytic converter off one of his work trucks, which occurred sometime within the past 2 months. There are no suspects at this time and no video footage available. **23-055800**

Loss Prevention advised that a known regular customer has been seen stealing items several separate times the past few weeks.
