**January 1, 2024**

- 0057 Multiple crews were dispatched to 2648 Parklawn in reference to a family problem. Investigation led to the arrest of **Christopher N. Engle (W/M/36)** for Domestic Violence and felony Strangulation against his live-in girlfriend. **24-000007**
- 0118 hrs Officers were dispatched to the 500 block of Aberdeen in reference to a female reportedly screaming for help and being chased outside. Contact was made with the male half, **Brett A. Ballentine (W/M/22)**, who showed obvious signs of being under the influence of drugs and alcohol, to the point he could not care for himself.
