POLICE BLOTTER

January 15, 2024

- 1157 hrs On 1/10/24, officers responded to Kroger at 2115 E. Dorothy on several theft reports, each with the same suspect. On 1/15/24, **Christopher R. Conner (W/M/27)** was identified and charged with Theft on reports **24-001650 & 24-001654**.
