POLICE BLOTTER

January 22, 2024

- 1118 hrs Officers responded to the Kettering Municipal Court for a subject turning himself in on an outstanding warrant. **Wesley A. Vittoe (W/M/20)** was arrested for a probation violation warrant entered through Miamisburg PD. **24-003633**
- 1558 hrs Officers initiated a traffic stop near Marshall/Lincoln Park. A passenger, **Naisha L. Pollock (W/F/50)** was arrested on an MCSO warrant for Possession of Cocaine (F). **24-003639**

As they reached the area of Stonebridge, the vehicle conducted a U-turn and fled the stop. Moments later, other officers observed the vehicle as it turned north onto Woodman and was obeying all traffic rules. They continued to follow from a distance while additional crews arrived. The vehicle entered the lot of Shell at County Line, at which point an intercept was conducted. When moving into position, the vehicle intentionally backed into Ptl. Colon, causing extensive damage to the cruiser. It then attempted to move forward, ramming the driver's door of Lt. Lambert's cruiser. The intercept however was successful, leaving the suspect with nowhere to go. The driver, **Alexander R. Love (B/M/24)** was arrested for Failure to Comply and 2 counts of Felonious Assault. **24-003934**

2247 hrs Officers responded to Austin Landing to meet with a Franklin PD unit on a warrant transfer. **Christianna E. Vaughn (W/F/21)** was arrested on a KMC warrant for FTA-Assault. She was booked in to the Montgomery County Jail. **24-003938**

Contact was made with described suspect, **Erica L. Montgomery (B/F/44)**, in front of the store. The male was only calling because he was angry that his girlfriend had just been arrested at a bar. At no point in time did he call for emergency services or for help on his behalf. Officers responded to his home multiple times in attempt to speak with him, but he would turn all his lights off upon their arrival and refuse to come to the door. The prosecutor approved charges, and warrants were signed on the male. On 1/26, several crews responded to 1488 Melrose Ave for a warrant service. The wanted subject **Lucas G. Andrasik (W/M/29)** was arrested without incident for Misuse of 911 System and two counts of Telecommunications Harassment. **24-002334**
