POLICE BLOTTER

January 8, 2024

- 0137 hrs Officers initiated a traffic stop near S. Patterson/Schantz. After investigation, the driver **John L. Marshall (W/M/66)** was arrested for Possession of Drugs (F) after he was found to be in possession of Crack Cocaine. **24-001167**
- 0204 hrs Officers initiated a traffic stop on a vehicle in the area of E. Stroop Rd. and Glengarry Dr. A male passenger, **Zachary J. Price (W/M/31)**, was found to have an entered felony warrant for a Parole Violation. The driver, **Rachel L. Rein (W/F/36)** was placed under arrest after suspected Methamphetamine and Fentanyl were located in her vehicle.

- 1215 hrs Officers were dispatched to the library located at 3980 Wilmington Pk on report of a female sleeping in the lobby. Officers made contact with **Cristy K. Critchell (W/F/33)**. She was arrested on an active FTA warrant through Kettering Municipal Court on the original charge of Assault. **24-001780**

0900 hrs Officers were dispatched to 3939 Stonebridge Rd. on report of an unresponsive driver in a vehicle, which was still on and in gear. Inside the car was **Corey Taylor (W/M/32)**, unresponsive with a handgun visible on his lap. The gun was secured, and Taylor eventually responded to officers, but was unable to stand without assistance. Dispatch had previously received calls about the same car weaving through traffic. KFD responded and transported Taylor to the hospital. A DRE responded to the hospital for further evaluation of Taylor. Subsequent to the investigation, Taylor was charged with OVI, Possession of Methamphetamine, Having Weapons While Intoxicated, Weapons under Disability, and Improper Handling of a Firearm in a Motor Vehicle. This investigation is ongoing. **24-02116**

2215 hrs Officers conducted a traffic stop in the area of Dixie and Dorothy. The driver, **Jason B. Black (W/M/36)**, was found to have an active felony warrant for Burglary out of Clark County. Black was arrested upon confirmation. **24-002190**
