### **February 19, 2024**

- 1541 hrs While on an investigation, officers observed a subject with a warrant. The subject was stopped and the warrant confirmed. **Joshua Gates (W/M/40)** was arrested on two original KPD warrants for drug possession and drug paraphernalia. **23-036466/24-008765**
