POLICE BLOTTER

January 29, 2024

- 1833 hrs Officers responded to the area of Wilmington and Rahn on a traffic accident. The driver of Traffic Unit #1 **Melanie T. Rose (W/F/33)** was showing signs of impairment and ultimately arrested for OVI. Rose refused the breath test at the jail. **24-004985**
