POLICE BLOTTER

February 26, 2024

- 0955 hrs Crews were dispatched to a residence on a call of two subjects physically fighting in the front lawn area. Upon arrival and investigation, it was determined that **Matthew P. Hitchcock (W/M/36)** had assaulted a family member. He was placed under arrest for Domestic Violence. **24-009880**
