## KETTERING CITY COUNCIL REGULAR MEETING MINUTES September 22, 2020

The Council of the City of Kettering, Ohio, met in regular session on Tuesday, September 22, 2020, at 7:30 p.m. in Council Chambers at the Kettering Government Center South Building, 3600 Shroyer Road. Mayor Patterson presided and the Clerk of Council, LaShaunah D. Kaczynski, recorded. This meeting was telecast live on the cable access channel.

Mayor Patterson led the audience in the Pledge of Allegiance and gave the invocation.

#### **PUBLIC HEARINGS**

## PUBLIC COMMENT ON LEGISLATION

Sterling Abernathy- He is here this evening to speak about agenda item number 5. It is a resolution to increase the spending on the police headquarters building renovation by \$550,000. The police headquarters building renovation is an \$8.3 million dollar project city council approved January 2020. The city issued bonds to borrow money to pay for this project, and interest payments will increase taxpayer costs to more than \$1.1 million dollars. This cost does not include the separate police training facility which was part of the original project. In the council workshop meeting two weeks ago, city staff gave a short briefing recommending this half-million dollar increase. A PowerPoint slide was provided that listed scope changes, layout modifications, existing building deficiencies and furniture equipment and additions pricing. The PowerPoint presentation did not show an itemized cost for each change. A generator costing \$35,000 more than estimated was the only cost detail that was shared with city council. How the remaining \$515,000 would be used was not explained by city staff. City Council asked a few questions during the meeting which then they indicated approval and moved on to another topic. Here are some questions regarding the half-million dollar increase that council did not ask:

- 1. Are there any other lower cost options?
- 2. If an increase isn't approved at all, what is the impact on the city? Would it be possible to finish the renovation for \$8.3 million dollars without spending an additional half-million dollars?
- 3. Is it possible that the reason for the cost overrun is due to the city preselecting a general contractor for this project instead of opening competitive bidding between multiple contractors? The assertion made for preselecting a general contractor during the design phase would lower costs.
- 4. The original project budgeted \$210,000 to cover unexpected items and contingencies. An additional \$550,000 would increase that amount to \$760,000. Is three-fourths of a million dollars for unlisted and contingency items reasonable as it pertains to this project?
- 5. The city paid \$400,000 to an architect engineer to design and engineer the building by drawing up plans. Why are the changes in building layout now being asked during the design process? How much of the \$550,000 is due to the layout change in the middle of construction?
- 6. What are the existing building deficiencies? Why weren't they anticipated by the architect during the design phase and included in the original budget? How much is required for these deficiencies?

In the past couple years, he has attended many council workshops and read documents that were sent to city council as it pertains to this project. He does not know the answer to any of these questions; does city council know the answers to these questions? The city council is the ultimate

decision maker on this project. Citizens expect our elected officials to be good stewards of taxpayer money. Good stewards are active by getting informed and asking questions about spending decisions they approve. If city staff were the only people responsible for project spending, the law wouldn't require council approval. Council should actively participate in and question the spending for this project, which has now escalated in cost to \$11.5 million dollars. Council should not approve this proposed spending increase until they are fully informed about it.
