# 7. ADOPT AN OAK TREE /OAK TREE PRUNING GRANT PROGRAM

The Adopt an Oak Tree and Oak Tree Pruning Grant programs provide a framework for the Town to spend down the Tree Mitigation Fund that better targets oak trees. As opposed to past expenditures that were used for pruning of all trees in the public right of way. Through these programs, the Town can take a decisive step to proactively expand and professionally maintain its native oak tree canopy, while including Loomis residents in the process. Both

programs are an opportunity to promote a healthy tree canopy needed for community enjoyment, and a vibrant, functioning ecosystems, while increasing public safety, wellbeing, and preserving the Town's rural character.

#### RECOMMENDED ACTION.

Staff recommends that the Town Council receive a presentation on proposed Adopt an Oak Tree, and Oak Tree Pruning Grant programs. Following the presentation, staff recommends that the Town Council provide feedback and adopt a resolution authorizing staff to launch the program.

# 8. **DEPOT SHADE STRUCTURE AND TREE PROJECT**

At the December 12, 2023 Town Council meeting staff presented a preliminary shade concept for Blue Anchor Park; At the February 13, 2024 meeting presented a revised concept of the project based on the statement and comments provided by the Public and Councilmembers. Staff has incorporated the feedback received from both council meetings and has prepared a final, staff-recommended, concept drawing for approval (See Attachment B). A power point highlighting this design will be presented at the meeting **RECOMMENDED ACTION**.

Receive a power-point presentation from staff for a capital improvements project that proposes to provide a combination of shade trees and a shade structure at the Loomis Train Depot Plaza and Blue Anchor Park. The updated design incorporates Council and community input from presentations made on December 12, 2023, and February 13, 2024. Following the presentation, staff recommends that the Council adopt a resolution approving the final concept drawings and authorizing staff to prepare plans and specifications, advertise, and receive bids for the project.
