ALLIED AGENCY ACTIVITIES UPDATE

South Placer Fire District Deputy Chief Matt Feely gave a status report on the calls and activities of the South Placer Fire Department. He highlighted the significant risk of fire due to excessive heat and dry conditions. Placer County Sheriff's Office – Deputy Bilodeau gave a status update on the calls and activities of PCSO in the Town of Loomis. He also highlighted the successful rescue of 13 hikers who were missing in the fire zone of the wildfire in the Royal Gorge area in Placer County.

Pam Blake: (comment read by Town Deputy Clerk as Pam Blake was in an auto accident in parking lot on her way to the meeting): Commented on the need to have a touch pad for opening the door at the library; the large number of fireworks going off on the 4th of July; and the cancellation of the summer swim sessions and upcoming concert due to the excessive heat.

Russ Kelley- Barton Road: Commented on the very large, very loud mortar they went off on the fourth.

Ann Baker: Spoke on the proposed extension of the Tax Measure that will be a measure on the November 5th ballot.

Ethan Brizzi spoke on the 2024-2025 budget.

Miguel Ucovich- Craig Court: Spoke on the need for the Town to follow the Quimby Act.

Shari Arribere – Asked if a Butcher shop was coming into Town, and if a school was going to be built on Sierra College Blvd.

7. PRESENTATION BY PLACER LOCAL AGENCY FORMATION COMMISSION (LAFCO)

Placer Local Agency Formation Commission, or Placer LAFCO, is a state mandated independent regulatory body whose role is to encourage the orderly formation of local governmental agencies, preserve agricultural and open space resources, and discourage urban sprawl through the review of city and special district boundary changes and the extension of the services they provide

RECOMMENDED ACTION:

Receive, review and offer comments on presentation from Placer County Local Agency Formation Commission (LAFCO) Executive Director Michelle McIntyre which will cover the sphere of influence update and service review that LAFCO will conduct in the next fiscal year for the Town of Loomis.

8. PROCESS FOR APPOINTMENT OF TOWN CLERK

At the March 5, 2024 election, the voters of Loomis approved Measure A, which made the position of Town Clerk an appointed position rather than an elected position. The current Town Clerk's term of office will end December 8, 2024.

The governing state law gives the Town Council two options, the Town Council can directly appoint the Town Clerk, or the Town Council can "be ordinance, vest in the Town Manager its authority to appoint the Town Clerk.

RECOMMENDED ACTION

Provide direction on the Town Council's preferred process for appointing a Town Clerk.
