4. GENERAL PLAN UPDATE 2020 INFORMATION AND SCHEDULE:

State General Plan Guidelines and good planning practice recommend that a community's General Plan be updated on a regular basis, typically at five and twenty-year intervals. The Town adopted its General Plan in 2001 and with the twenty-year life span of the 2001 General Plan nearing, it is appropriate to update the General Plan to reflect the Town's existing conditions, changes in Federal and State regulations, changes to the State General Plan Guidelines, changes in technology, changes in the economy, and to assure the General Plan is internally consistent.

Recommended action: Receive information, take public comment and discuss the Town's next steps.

Public Comment:

David Ring – Delmar: Asked about new technology (ie Drones) being included in the General Plan update; Inquired if the October 8 joint PC/TC meeting is open to the public and asked for clarification of RHYNA number updates what they mean to the town.

Commissioner Comment:

Commissioner Wilson:

Asked for definition of VMT and opened a discussion regarding VMT
asked for further explanation on the stated advantage of tiering off the County's traffic study - analysis, process etc.
Inquired about homeless shelter requirements.
Asked about the process involving spot zoning requests that come up during the update process.
Asked about how large lot zoning is affected in the requirements of new housing.
Asked about the process – Steps, timing, studies involved, community engagement etc.

Commissioner London:

Voiced concerns over and asked for direction in addressing new state housing laws and RHYNA requirements
Asked if during information gathering, does it tie into the new 2020 census information; or another source (we will use the current CA department of finance data).
Commented that town talks will be a good source/venue for sharing information and answering questions regarding the general plan update.

Chairman Obranovich:

Are alternate methods of transportation considered into the VMT analysis?

Commissioner Hogan:

Stated his main goal is to eliminate the inconsistencies between the General Plan and the Zoning Code.
