LOOMIS CHAMBER OF COMMERCE UPDATE

Jenny Knisley noted the following:

- on April 19th the Chamber will be hosting the Placer County Economic Development Board

9. **Downtown Master Plan Phase 1**
 Loomis Public Works prepared bid documents to provide pedestrian improvements on Taylor Road from Horseshoe Bar Road to Oak Street which will provide new curb, gutter, sidewalk, high visibility crosswalks and restriping of the roadway to facilitate bike lanes. Staff is requesting Council to award a construction contract and authorize Town Manager to execute.
Recommended action: Take public comment and adopt Resolution awarding construction contract to Martin Brothers Construction, Inc for the Downtown Master Plan Phase 1 and authorizing the Town Manager to execute a contract acceptable to the Town for providing such construction services in an amount not to exceed \$2,422,911.
Public comment:

Jenny Knisley stated the following:

- the Loomis merchants have met and have talked about the trees
- she asked that we have a finished product when this is completed and not have it without the landscaping for a long time

Katy Thompson stated the following:

- the Flower Farm talked to the Sac Tree Foundation, they are willing to help and they have some ideas on how they replace trees
- they have talked about having a sub-committee to look at each tree to get some feed-back
- the merchants would like this done right and close together for the least amount of business impact as possible

Brit Snipes, Town Engineer/Public Works Director, stated the following:

- the planting portion of the landscaping he put into a separate bid alternate which came back with two extremely different prices
- he recommended not accepting the bid alternate at this time and he will bid it as a separate landscaping project
- he has been meeting with the merchants and one of their concerns is the existing trees between Horseshoe Bar Road and Walnut Street
- they have grown to where they are blocking the signs
- in the landscaping package he was directed to save all the trees he could save
- we have a schedule of trees that we will replace them with and the merchants would like to see the trees that we are scheduled to plant
- he plans on meeting with them before the bid package is finalized for the landscaping planting plan and if they want to suggest some different trees than he will bring that back to the council
- the Flower Farm and High Hand Nursery have both offered to donate some trees
- there is also the tree mitigation fund that is available to cut costs

Councilmember Ucovich pointed out that the existing trees have grown large enough and have been trimmed up enough that you can see all the signs for the businesses.

Katy Thompson stated that the trees are also blocking street signs, polluting the historic buildings (leaves are clogging the drains), and some are pulling up the sidewalks.

Following further discussion on the matter, a motion was made to approve Resolution 17-07, awarding construction contract to Martin Brothers Construction, Inc for the Downtown Master Plan Phase 1 and authorizing the Town Manager to execute a contract acceptable to the Town for providing such construction services in an amount not to exceed \$2,422,911. On motion by Councilmember Ucovich, seconded by Councilmember Morillas and passed by the following vote:
