### 1. The Village at Loomis

To consider applicant's request to amend the Loomis General Plan; Rezone the Project Site to the Planned Development (PD) District; Approve the Village at Loomis Preliminary Development Plan, Development Standards, and Design Guidelines; Approve Specific Development Plans for Village Areas 1, 2 and 3; Approve the Village at Loomis Tentative Subdivision Map; and the Village at Loomis Development Agreement; subject to the Certification of the Village at Loomis Final Environmental Impact Report (FEIR) as required by the California Environmental Quality Act

**Recommended action:** Staff recommends that the Town Council (Council) receive a presentation from the Applicant regarding revisions to the project in response to Council direction, receive Staff's presentation, receive public comment during the public hearing, and that the Council consider each of the entitlements needed for the proposed project. This is a discretionary process, meaning that Council has the ability to either approve or deny the project, after weighing the project against the totality of the Town's existing planning documents.
