PUBLIC HEARING

1. **Extension of an Urgency Ordinance**

Consider an Urgency Ordinance of the Town Council of the Town of Loomis Extending Urgency Ordinance No. 268 which Established a Temporary Moratorium Prohibiting the Outdoor Cultivation and Sale of Non-medical Marijuana

Recommended action: Take public comment; adopt an uncodified urgency ordinance by 4/5 vote of the Council extending the moratorium on the outdoor cultivation of non-medical marijuana and prohibiting the sale of non-medical marijuana; and find that the ordinance is not subject to California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Sections 15060(c)(2), 15061(b)(3) and 15308.

Public comment:

There was no public comment.

Joan Phillipe, Interim Town Manager , stated the following:

- at the December 13, 2016 Council meeting the Council adopted an Urgency Ordinance that was in effect for 45 days, which is up Friday the 27th of January 2017
- the Government Code provides for an extension of the Urgency Ordinance for one of two periods, either 10 months and 15 days or 22 months and 15 days
- staff is recommending to do the 22 months and 15 days, primarily because we have a new town manager coming on board and this will give more time for that person

Following further discussion on the matter, a motion was made to adopt Ordinance 269, an Uncodified Urgency Ordinance of the Town Council of the Town of Loomis extending Urgency Ordinance 268 that established a temporary moratorium prohibiting the outdoor cultivation and sale of nonmedical marijuana for 22 months and 15 days. On motion by Councilmember Onderko, seconded by Councilmember Ucovich and passed by the following vote:
