I would like to invite all interested parties to observe Election Day proceedings for the June 18, 2019 Special Municipal Election for the Town of Loomis.

The Elections Office welcomes interested voters to our office on, before, or after Election Day to observe the staff process mail ballots and perform other election activities. However, it is suggested that you call ahead to ensure election activities are being performed during the timeframe(s) you wish to stop by.

It is the goal of the Placer County Elections Office that our elections be as transparent as possible. We invite you to observe any election processes.

Logic and Accuracy Testing of the AccuVote-OS and TSX will begin around May 27, 2019. The testing location is the Placer County Elections Office, 2956 Richardson Drive, Auburn. For further information about dates and times, please call 530-886-5650.

On Election Night, observer activities will begin just after 8:00 PM at the Elections Office, located at 2956 Richardson Drive, in Auburn. We would encourage you to arrive before 8:00 PM to witness the closing of the polls and posting of results. I believe those who have participated in the past have come away with a greater understanding and knowledge of the election process.

At 8:00 PM, we will release the results of the vote by mail ballots processed during the previous ten business days. The polling place results will begin arriving sometime after 10:00 PM. This will be followed by periodic updates throughout the evening. Election Night activities could end as early as 12:00 AM or as late as 2 AM. The end of the day is unpredictable, and you are welcome to leave at any time during the evening.

On June 19, 2019 at 10:00 AM, the Placer County Elections Office will randomly select the precincts that will be used for a manual tally of one percent (1%) of the precincts casting ballots at the June 18, 2019 Special Municipal Election. On June 24, 2019 at 9:00 AM the Placer County Elections Office will begin this one (1%) percent manual tally. This tally is also open to the public.

Our office will begin mailing mail ballots on May 20, 2019 and will start processing voted ballots on June 4, 2019.
