Notice of Opportunity to Serve on a General Plan Update Committee

The Town of Loomis invites interested parties to participate in the General Plan Update process by serving on focused committees. We are looking for your unique experience and knowledge in this process to help the Town meet General Plan goals through policies and implementation. The committees will provide the Town Planning Commission and Town Council with local insight and solutions for specific topics.

Committees will be expected to confirm the setting reflects the existing conditions in the Town, and recommend a vision statement/guiding principles, goals, objectives, policy, an implementation programs for the topic area to which they are assigned. Committees will typically consist of five members with potentially up to ten members appointed by the Town Council, with a Council Member chairing the committee and a Planning Commissioner serving as Vice-Chair. Committee voting members may consist of Loomis property owners, businesses, and/or residents. Persons outside of Loomis wishing to share their expertise or experience may serve as non-voting auxiliary members.
