MATTERS OF INTEREST TO COUNCILMEMBERS

Councilmember Baker thanked Russ Kelley, American Legion, and the Chamber for the decorations, tree and the lighting.

Sean Rabe, Town Manager, gave an update on COVID-19, mailbox thefts and vandalism, Rural Main Street Technical Assistance Program, and Costco.

LOOMIS CHAMBER OF COMMERCE UPDATE

Ryan DeMartini, Loomis Chamber of Commerce President, pointed out the Chamber Board met to discuss how they can best assist the businesses and working with Placer County and other local Chambers on the Shop Placer Program, where they promote shopping locally.

5. Treasurer's Report

David Ring stated that \$250,000 is invested in Exon Mobile, pointed out that their net worth has fallen, they have been laying off employees over the last decade and no longer contributing to employees retirement plans, this doesn't sound like a company that we should be investing in. Asked council to re-invest into something else.

Roger Carroll, Finance Director/Town Treasurer, stated we are not required to keep any investment to maturity, right now Exon Mobile is still properly rated and it's a solid investment though he will consider it.

BUSINESS

10. Loomis Library Building Purchase and Sale Agreement

Placer County announced the closure of the Loomis Branch Library in February 2014. That action led to significant public outcry and concern, which eventually culminated in the Town taking several actions intended to save the Town's library. Those actions included entering into a 10-year lease (June 2016) and the successful passage of a 1/4-cent sales tax measure, intended to fund the operation of the Library. In 2016 the Library was operated by the Friends of the Library and in 2019 the Town transitioned the operation of the Library to Town staff by creating a new library department and hiring full-time staff. Town staff began working with Placer County on the potential purchase of the Library Building and property. The results of that work is now presented to Council for approval tonight in the form of a purchase and sale agreement for the building and property.

Recommended action: Adopt Resolution approving a Purchase and Sale Agreement with Placer County for the Loomis Library building and authorize the Mayor to sign the agreement. **Public comment:**

Supervisor Jim Holmes stated the following:

- the Loomis community and the Friends of the Library were really engaged to get this resolved and save the library
- today is an historic moment and a great resolution for the Town of Loomis

Jean Wilson stated this has been a five and a half year struggle to get the Library where it is today and thanked everyone that put a lot of work into it.

Miguel Ucovich asked Council, in the future, to consider purchasing an additional 2 to 3 acres adjacent to the Library for additional space for expansion or parking.

Following further discussion on the matter, a motion was made to adopt Resolution 20-51, authorizing the purchase and sale agreement of a certain property (Library). On motion by Councilmember Clark-Crets, seconded by Councilmember Baker and passed by the following roll call vote:

11. General Plan Update – Housing Element Committee Assignments

Newly elected Councilmembers Jenny Knisley and Danny Cartwright will select a public member to serve on the Committee. In addition, on November 10th, Mayor Clark-Crets selected Sonja Cupler to serve on the Committee, however, Ms. Cupler has withdrawn her application so Councilmember Clark-Crets will need to select a new member. In total, there will be nine members serving on the Housing Element Committee.

Recommended action: Councilmembers Clark-Crets, Knisley and Cartwright to appoint Housing Element Committee members, following the previously approved Committee Structure, to serve on the General Plan Update Housing Element Committee.

Public comment:

Mary Beth Van Voorhis, Town Planner, gave an update from the previous meeting:

- Mayor Jeff Duncan will be the Chairman on the committee and Commissioner Greg Obranovich will be the Vice Chairman
- each council, at that time, appointed Gary Liss, Matt Fox, David Ring, Russ Kelley and Sonja Cupler (who has recently requested to withdraw)
- the two auxiliary members, chosen by the Chairman and the Vice Chairman, are Jean Wilson and Ed Horton
- at this time, we are looking for Councilmembers Cartwright, Clark-Crets and Knisley's appointments to serve on the Housing Element Committee

Councilmember Clark-Crets appointed Maureen Valli on the Housing Element Committee.

Councilmember Cartwright appointed Thomas Savage on the Housing Element Committee.

Councilmember Knisley appointed Chiara Mosher on the Housing Element Committee.

Miguel Ucovich asked what time the meeting will be tomorrow.
