### MATTERS OF INTEREST TO COUNCILMEMBERS

Councilmember Ucovich asked the following:

- how did SACOG get their numbers for the 2018 Metropolitan Transportation Plan (MTP) build-out estimates
- he would like to have a schedule on when there will be improvements on the roads in town

Councilmember Duncan stated the following:

- pointed out that Sunrise Loomis park looks nice now
- he suggested having an extra garbage can by the restrooms

### TOWN MANAGER REPORT

Sean Rabé gave an update on the following:

- we have a new code enforcement officer who is working on cleaning up some areas in town
- the town is eligible for a \$5000 grant each year for recycling containers and he submitted the grant two weeks ago
- we can put more trash cans around town and out at the park and Recology has offered to pick the cans up along Taylor Road with no charge

Brit Snipes, Town Engineer/Public Works Director, stated that South Placer Municipal Utility District (SPMUD) has been coming across a lot of rock and is boring under Horseshoe Bar Road and will be boring under the freeway and coming out behind Raleys.

### LOOMIS CHAMBER OF COMMERCE UPDATE

Jenny Knisley stated the following:

- they had a joint chamber meeting at the Flower Farm and had over 144 officials
- the Discover Loomis magazines are in
- the Loomis Community yard sale will be on May 5<sup>th</sup>
- they will be having an extra Friday Fest on May 11<sup>th</sup> along with the Town Concert

Jenny Knisley, Loomis Library Board Member, asked if the sign could be moved closer to the library building.

Mayor Morillas suggested Zach talk to Jenny Knisley on where to put it on the lot.

Dennis Oliveira, Rachel Lane, stated the following:

- he questioned Councilmember Onderko's statement of economic interest that he filed on March 2, 2017 noting that he was a board member of California Housing Partnership Corporation for a period covering January 2016 through to the end of December 2016
- on the California Housing Partnership website he noticed that Councilmember Onderko is still listed as the Secretary of that organization
- he is confused about the status and asked at some future date if Councilmember Onderko could address that

William Quenneville, Horseshoe Bar Road, noted the following:

- property crime is getting worse in Loomis
- asked Council to look into this with Placer County Sheriff's Department
